# He reported as follows:

- 1 Westbury Care Home will be going on the market to be sold and the Parish Council will be notified.
- 2 A further £4m has been allocated to GCC for Highways. This is in addition to the £100m which is in the budget. Last year 39,000 potholes have been repaired. There is strict criteria that needs to be met before potholes are repaired. GCC are trailing a cold lay system called viafix which may prove to be much better in repairing potholes in difficult weather conditions. The downside is that it is very expensive
- 3 Road Safety Community Speedwatch Scheme: This is a joint scheme between GCC and the Police GCC has put in £550k and the Police £50k. 70 cameras have been allocated to Town and Parish Councils and those that have been installed are getting good results with persistent speeding offenders being identified, incidence of false number plates on a vehicle which has been linked to other crimes. The scheme is also funding VAS signs and 6,000 wheelie bin stickers have been issued. 190 Town and Parish Councils have expressed interest in the schemes
- 4 Tree Planting: The planting seasons is coming to an end with 220,000 trees being planted. The aim is to plant 1m trees by 2030
- 5 Funding available for Youth Projects of up to £3,000

**Westbury Care Home:** The Chairman raised the fact that the electric cupboard is open and easily accessible which could cause a danger. Also one of the 2 skips on site has a large hole in it.

**Westbury Surgery:** The Chairman asked if CC Robinson could try and find out what was happening with regards to the future of the surgery. He agreed that following the meeting with the NHS everything had gone very quiet with regards to the provision of a road crossing/bus stop. He would make some enquiries with Carole Alloway-Martin who is the CC cabinet minister for adult social care commissioning.

- **8.3)** Audit for the year ended **31** March **2023** Audit report and sign accounts: Clerk reported that Shirley Fowler had completed the Internal Audit and reported as follows:
- Applied the tests as set out in Appendix 8 of the Practitioner's Guide Governance and Accountability in Local Councils in England and Wales and found the results to be satisfactory.
- Confirmed that Risk management procedures currently in place are completely appropriate, sufficient, and very well monitored in accordance with the Risk Management file.
- Tested payment procedures as adopted against receipts/invoices, cheques drawn and bank statement entries and found these to be satisfactory, also leaving a good audit trail.

Mrs Fowler had therefore completed and signed the Annual Internal Audit Report section of the accounts. She had submitted her invoice for these services.

- **8.4)** Audit for the year ended **31** March **2023** Signing of Annual Governance Statement the Clerk took the Councillors through this and agreed response. The Chairman and Clerk arranged for the Statement of Assurance.
- **8.5)** Audit for the year ended **31** March **2023** Signing of Accounts the Chairman and Clerk arranged for these to be signed.

## 9 MATTERS ARISING:

- **9.1) Highways Matters:** The Chairman said he was still trying to organise the tour of the Parish with Glos Highways and CC Robinson there is so much to see, and he has a very long list of problems to report.
- **9.2)** Burial Ground: Proposed extension: The Chairman reported that Smiths will commence the fencing works week commencing 29 May. He has informed the Head Teacher the timing is good as it will be half term when the main fencing works will be done. He had also walked to the new seeded playing field and the ground is considerably firm. The grass has taken very well. **The Clerk is contacting Smiths to ascertain the cutting and weed killing schedule.** It was agreed that the Clerk should apply for the £20,000 PWLB grant to be able to finance the fencing works.

The Clerk reported that despite several chasing emails to Hayley Fearnside, a rental figure for the new playing field is yet to be agreed. Until the rental figure is agreed, the new leases cannot be drawn up. The Chairman said he would chase up Richard Williams as Hayley Fearnside wants to speak with him.

**9.3) Play Area:** Councillor Townsend said that he would carry out more wetpour patching now the weather is better.

- 9.4) Footpaths: Councillor Townsend had nothing to report
- 9.5) Climate Change: Councillor Landon had nothing to report
- **9.6) Westbury Drs Surgery:** Discussed in the Annual Parish Meeting. No further progress has been made. CC Robinson to see what he can find out.
- **9.7) Watchtower Walmore Common:** The Chairman reported that when he was out campaigning, he spoke with the Webbs about looking into getting the Watchtower listed with English Heritage. After a conversation with the family and hearing their thoughts on the matter he felt the Parish Council should not pursue this matter any further with English Heritage.
